

WARRANTY POLICY

1. General Provision.

Aeropol Aviation Services Corporation (AAS) warrants that subject to all of the terms of this Warranty, the Equipment overhauled or repaired by AAS shall conform to applicable drawing and specifications and be free from defects in material and workmanship. The terms of Warranty shall begin upon the delivery of the Equipment to the Customer and excludes any costs of delays/consequences of delays (directly or indirectly), or any damage during the course of the shipment.

 (a) Re-certification and Bench Test: Units functionally tested and/or time re-certified only, will not be covered by any warranty.

(b) Accessory Repair and Overhaul Warranty.

AAS warrants the following to be free of defects in material and workmanship, under normal use and excluding normal wear items, for the following periods: This warranty coverage applies only to component parts replaced and the circuits and/or functions of the unit that were repaired. Cost of components, circuits and/or functions not repaired or replaced during initial repair will be the responsibility of the customer.

Accessory overhaul – 12 months or 600 hrs of normal operation, whichever comes first from the date of receipt of the unit by the customer.

Accessory repairs – 6 months or 300 hrs of operation, whichever comes first on the functions or portion of the unit repaired by AAS. This warranty does not give full coverage on any failure during this period, but covers parts and labour used in the previous repair. Warranty on **pre-owned and surplus units** purchased outright from AAS will be determined at the time of purchase.


(c) Exchanges: Exchange units depending upon their condition, will be covered under the above detailed clause 2(b) of this warranty policy; provided that the exchange transaction has been completed, and all the terms and conditions of the exchange agreement have been met.

New manufacturer or manufacturer's overhaul exchange units will be covered exclusively by the manufacturer's warranty provisions. The manufacturer's warranty determination will prevail.

- 3. Parts Warranty.
 - (a). New Parts sales are subject to "Manufacturer's" warranty condition.
 - (b). Used Parts sales are sold "As Is' or serviceable condition.

Notice of any claim under this Warranty must be provided in writing to AAS within thirty (30) days of Customer's discovery of the defect. At AAS request the Customer must also provide such additional documentation as may reasonably be required by AAS to make a warranty claim adjudication.

This warranty shall not be extended, altered or varied except by a written instrument signed by AAS.

4. Exceptions and Exclusions.

AAS will either repair or replace, at its option, any unit, which fails during the warranty period. Cost of removal, installation and all shipping charges, customs duties, taxes, tariffs, or other related charges will be the sole responsibility of the customer. All shipments should be insured for replacement value. Proper packaging technique must be used or any warranty benefits may be voided.

The warranty is void if the unit shows signs of abuse, alteration, broken seals, improper installation, or improper packaging for shipment. Returned core units must be in economically repairable condition.

This warranty shall not apply where the equipment has been used, handled, stored, maintained, installed or operated contrary to sound aviation industry practice, written instructions provided by AAS or the equipment manufacturer, and the requirements of applicable Airworthiness Authorities.

This warranty shall not apply when defects are caused by normal wear and tear.

This warranty is the only expressed warranty made and there are no other warranties except made herein. Repair and replacement as provided herein are the exclusive remedies for a breach of this warranty. Implied warranties of merchantability or fitness for a particular use are limited in duration to the express warranty given herein. There is no warranty covering consequential damages or incidental expenses, and AAS shall not be liable for any such claim. This warranty gives the Customer specific legal rights. The Customer may have other rights, which may vary from jurisdiction to jurisdiction.

ALL WARRANTY POLICIES APPLY, UNLESS OTHERWISE SPECIFIED IN WRITING.

THIS WARRANTY SHALL BE IMMEDIATELY EXTINGUISHED IF THE EQUIPMENT IS DISASSEMBLED, TAMPERED WITH, ALTERED, MODIFIED OR REPAIRED BY ANYONE OTHER THAN AAS, OR INVOLVED IN AN ACCIDENT OR INCIDENT.
